THE TERMS THAT MATTER MOST

Month to month	Enrollment continues monthly until either party gives written notice. Notice at least 14 days before the 1st avoids the next month's billing. No semester commitment, no contract.
Tuition	Billed in advance on the 1st. It reserves your weekly time for the month, not a number of lessons. Tuition already paid is not refunded or prorated. Rates may change on 30 days' notice.
Missed lessons	A lesson you miss is not refunded. With 24 hours' notice we will try to offer a makeup, subject to availability — a courtesy, not an entitlement. Lessons we cancel are rescheduled or credited.
Minors	We are not a childcare facility and do not supervise outside the lesson. Children under 13 must be accompanied to and from lessons and to every family gathering. Ages 13–17 may be dropped off only if authorised on page three.
Not medical care	Voice and piano instruction is education, not medical, therapeutic or diagnostic treatment. Take any concern about voice, hearing, hands or health to a qualified clinician.
Instruments	Some activities take place in a working piano gallery. You are responsible for the cost of damage caused by you, your children or your guests. No food or drink near the instruments.
Alcohol	Not served or permitted at any Studio activity unless we designate an event in writing as one at which alcohol is present — those are 21 and over, and never where minors attend.
Texas law	Governed by Texas law. Venue in Harris County. We will attempt direct resolution and then mediation before any proceedings.
